### RoHS / REACH STATEMENT

MPE Electronics is dedicated to providing high quality products that meet environmental regulations for the use of certain hazardous substances in electrical and electronic equipment (EEE), RoHS and REACH.

As MPE Electronics are a sub-contract manufacturing service for customer designed product and do not hold design authority, we predominantly rely upon our customers to specify compliant products via manufacturers' data sheets etc. Within the manufacturing process and where it is reasonably within MPE Electronics scope of control, we are fully compliant with RoHS and REACH Regulations, unless contractually agreed with exempted customers.

#### **RoHS Compliance**

In Great Britain and Northern Ireland, manufacturers, importers and distributors, which include retailers, (known as economic operators) are responsible for the compliance of EEE that they place or make available on the GB and/or NI market.

Economic operators in Great Britain and Northern Ireland must be able to identify who supplied them and who they supplied for 10 years following the placing on the market of the EEE.

Manufacturers placing EEE on the market in Great Britain and/or Northern Ireland must evaluate their production controls to ensure that their products do not exceed the maximum prescribed levels of the following hazardous substances:

Restricted Substance	Maximum Threshold Limit
Cadmium and its compounds	0.01 %
Mercury and its compounds	0.01 %
Hexavalent chromium and its compounds	0.01 %
Lead and its compounds *	0.01 %
Polybrominated biphenyls (PBB)	0.01 %
Polybrominated diphenyl ethers (PBDE)	0.01 %
Bis(2-Ethylhexyl) phthalate (DEHP)	0.01 %
Benzyl butyl phthalate (BBP)	0.01 %
Dibutyl phthalate (DBP)	0.01 %
Diisobutyl phthalate (DIBP)	0.01 %

- Certain customers require parts that are not RoHS compliant. MPE Electronics Produces these when contractually agreed.

#### **REACH Compliance**

In accordance with Article 57 of UK REACH concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH). This Regulation establishes specific duties and obligations for companies in the UK that manufacture or import substances on their own, in preparations, or in articles.

- Under the structure of the REACH Regulation, MPE Electronics is a manufacturer and supplier of "articles". We do not manufacture or supply "substances" or "preparations" and our articles do not involve the "intentional release of "substances". Accordingly, we foresee no registration or pre-registration requirement for the products we supply to you.
- MPE Electronics is constantly monitoring the substances of very high concern (SVHCs), as defined by REACH, in our products. This will be an on-going process since the complete list of SVHCs will be released in stages.
